Minutes

Board meeting of Park County Rural Fire District #1

May 20th, 2024

The Board of Trustees of Park County Rural Fire District #1 met on May 20th, 2024 for their regular meeting at 304 East Park Street, Livingston MT.

Trustees Present: Chairperson Lawellin, Secretary Lowy, Trustee Fee, Trustee Nelson, Trustee Donovan

Also Present: Chief Babcox, Vickie Jo Shipley, Andy Mitchell, Jordan Caoile

Call to Order: Meeting called to order at 6:00pm

Public Comment: Chairperson Lawellin brought to attention Chief Babcox's request to divert money that was fundraised for the department to the association. The total amount was \$16,000, and Chief Babcox wants to donate 25% (\$4,000) to the association. Chairperson Lawellin stated that it would be placed on the next meeting agenda.

Minutes: Minutes from the April 8th meeting and the special meeting on May 6th were read by Secretary Lowy. On the April minutes, Trustee Donovan voiced that there were a lot of changes he would like to make before they are approved and submitted. Secretary Lowy asked if an addendum could be added to the minutes. Chairperson Lawellin responded that no addendum can be added. Chairperson Lawellin told Trustee Donovan he needs to come to the board with specific changes he would like to make to the minutes. Trustee Donovan asked to take the minutes to the next meeting for approval to get the changes he would like put together. A motion was made to postpone accepting the April minutes until the next meeting by Trustee Nelson. Second by Trustee Fee. Motion passed. Secretary Lowy opposed.

A motion was made to approve the special meeting minutes from have as amended by Trustee Fee. Second by Secretary Lowy. Motion passed unanimously.

Sign Claims and Warrants, Financial Report for: See Attached. Financials were read by Vickie Jo Shipley. Signed and approved April 9th-31st warrants and claims #15062-15077 15078=\$39,669.92. Signed and approved May 1st-20th warrants and claims #15078-15117=\$71,970.25. The current bank balance without April income is \$72,033.73. Capital

improvement fund has \$122,888.57. Mrs. Shipley informed the board of the change in the previous months claim numbers. The memo was written 15048-15050 for April 1st-8th warrants and claims and it should be noted and changed to April 1st-8th 15048-15060. Trustee Nelson and Donovan inquired about the check register in the board packet. Mrs. Shipley reported to the board that is was forgotten in the board packet but done. (The check register was printed out and handed to all board members later during the meeting). A motion was made to accept the financial report without the check register by Trustee Nelson. Second by Secretary Lowy. Motion passed unanimously.

Old Business: Discussion/decision and update on the website. Lieutenant Caoile walked the board members how to access the website, as well as what the new updated website looks like. Trustee Nelson voiced wanted to be able to access the Fire department page from the County page that shows the commissioner meetings and information from county entities. Chief Babcox explained that the department is a special board not under the commission as the other groups in Park County which is why it is not listed on their information. Trustee Nelson voiced her concerns for a layperson trying to access the site that they will look under the county web page not Rural Fire. Lieutenant Caoile explained that if they are looking for rural fire specifically and type that into the search bar it will direct them to the department address as well as the link directly to the page. Chief Babcox showed how easy it is to navigate the website to the department page as well. It was voiced by the majority of board members to keep all dates and information on the webpage current, and to upload all minute documents.

Discussion/decision on By-Laws and Code of Conduct. In the board packet was a Code of Conduct for the Board to adopt to the By-Laws as an addendum. It was asked of the board what they thought of the code of conduct and if there were any additions or changes they would like to make. It was brought to attention a possible change in Article 4 Subsection 3 #4. Trustee Nelson asked to have a special meeting or to move the discussion/decision to a later date for more time to review. A motion was made to table discussion/decision on the code of conduct to the next meeting by Secretary Lowy. Second by Trustee Fee. Motion passed unanimously.

Discussion/decision on updating and approving the SOP/SOG. Chief Babcox voiced that the purpose of the SOP/SOG is how the district operates, it is not intended to govern. There is a separate document related to behavior. The SOP covers as a guideline how to respond and actions to take depending on each type of incident, i.e. Structure, Wildland, etc. The SOP/SOG was started on, but then dropped. It was voiced that having a 25-page document does not make sense. Primarily these documents are about safety and protocol. Chairperson Lawellin voiced that they can be taken by a series a month and have them reviewed with the board giving direction. Chief Babcox voiced that he planned to start in August with the 100 series, coming with a copy of the old SOP/SOG and a document of what needs to be changed. Within the

SOP/SOG it is stated that is by the Fire Chief or his designee. Chairperson Lawellin asked if the 100 and 200 series could be done before August. Chief Babcox said they could be done in July.

New Business: Discussion/decision on the preliminary budget for FY25. There will need to be a special meeting in June to amend the current budget for FY24 and approve FY25. It was asked if there are any loans falling off this fiscal year, which was no. Mrs. Shipley voiced the main changes would be in wages for the new Assistant Chief and the increase in the Chief's wage. It will be decided later when the special meeting will happen as this was a preliminary discussion.

Public Comment: Trustee Nelson voiced to the board that at the next county commissioners meeting Trustee Nelson and Secretary Lowy were on the agenda for acclimation to the board seats. Chairperson Lawellin is not on the agenda but is set to be appointed. Chairperson Lawellin voiced the date of the July meeting is July 8th and if the board members were okay with moving the regular meeting to the Monday after on July 15th. All board members were good with moving the regular meeting to July 15th, 2024.

Adjournment: A motion was made to adjourn the meeting by Secretary Lowy. Second by Trustee Nelson. Motion passed unanimously. Meeting ended at 8:02.
