We also give away 50+ goody bags, prizes and transform the space into a magical wonderland!

Beyond the festivities, our event partners with local nonprofits. They help and staff Mrs. Claus' Kitchen, receiving reduced rental fees for future events and all profits from breakfast and tips. Previous partners include the Livingston Ice Skating Association, Sister City, Boy Scout Troop 516, Park County Motor Vehicle Park and the Cool Café for youth.


What you get. Sponsors will receive the benefits specific to the opportunity they purchase as listed in the diagram below.
